Executors, Administrators and Assigns, hereinafter referred to as **DES** for the sake of brevity) **The party of the first part.**

And

**SAHYADRI HOSPITAL PVT LTD**, (Previously known as **SAHYADRI HOSPITAL LTD**) a company registered under Companies Act, 2013 with **CIN U85110PN1996PTC099499** and having its Registered Office at **S.NO.89 &90, PLOT NO. 54, LOKMANY COLONY KOTHRUD, PUNE - 411038** duly represented by **CHIEF EXECUTIVE OFFICER MR. ABRARALI DALAL**

(Which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Directors, their successors and permitted assigns, herein after referred to as '**SHPL**' for the sake of brevity) **THE PARTY OF THE SECOND PART.**

**WHEREAS,**

- A.** The DES a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines.
- B.** The DES has established college in the name D.E.Society's Brijlal Jindal College of Physiotherapy with appropriate permissions from Government of Maharashtra and is affiliated to Maharashtra University of Health Sciences, Nashik ( hereinafter referred to as the said "**COLLEGE**"),
- C.** SHPL is a company incorporated and registered under companies Act, 2013 and having its main objects of establishing and running hospitals and health care facilities. SHPL is presently running / managing various hospitals, pathology labs and diagnostics centers in Pune as well as the rest of Maharashtra. SHPL is running and managing Sahyadri Super Specialty Hospital located at Karve Road, Pune (hereinafter referred to as the said "**HOSPITAL**' for the sake of brevity ).
- D.** For mutual benefits, the parties hereto agree that for imparting of practical training and examination of the students as contemplated by the concerned syllabus, the said College is permitted to send students up to its intake capacity, in batches each comprising of about 25 – 30 students led by its faculty members, to the said Hospital, in view of the said College paying Consideration as stated in clause D herein below of this MOU excluding examination period & vacation to on the terms and conditions enumerated below
- E. NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:**
  - A. SCOPE :**

The scope of this understanding extends only to deputation of the students by said college up to intake capacity for all classes, for imparting of practical training and examination as contemplated by the concerned syllabus for the discipline/s in batches each comprising of about 25-30 students led by its faculty members to the said Hospital and other incidental and ancillary matters related thereto.

**B. DURATION:**

- 1 The duration of this understanding shall be for a period of three academic years i.e. from **01<sup>st</sup> June 2021 to 31<sup>st</sup> May 2024**, unless renewed in writing by both the parties.
- 2 Both the parties can cancel or terminate the present MOU by giving 3 months prior notice in writing to other party. However, in case of breach of any of the terms of this MOU, SHPL reserves the right to terminate this MOU forthwith.

**C. OBLIGATIONS**

**(a) Obligation of SHPL :**

- 1 SHPL hereby agrees and permits the college to depute students up to its intake capacity, in batches each comprising of about 25 – 30 students led by its faculty members, to the said Hospital for imparting of practical training and examination of students as contemplated by the concerned syllabus.
- 2 Provide support and facilities to the College to hold practical training in consonance with the syllabus prescribed for the Course in the premises.
- 3 Designate one of its officials as a single point contact to decide and resolve all issues pertaining to the smooth operations of the training part of the Course covered within the scope of this MOU and shall communicate his / her name and contact details to the said College .
- 4 Allow the students and training providers to enter the Hospital premises for the purpose of attending training sessions; the Hospital reserves the right to restrict any student or person from entering its Hospital premises for any disciplinary or other issues.

**(b) Obligations of DES :**

1. The said College shall acquaint the students with the norms of discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from entering premises of the said Hospital.
2. The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said hospital.
3. Ensure that students follow discipline, directives and decorum on the campus of the Hospital. Allow the representatives of the SHPL to check and inspect the conduct of part of

the Course, which forms part of the MOU and call for any information and take copies of the documents and records concerning the Course any time, only if required to be produced by SHPL, under any direction issued by any statutory authority or in compliance of any other law. However, before any requirement, the SHPL shall issue 15 days' notice to College to take appropriate action and make arrangements.

Comply with the applicable laws relating to its activities, students and employees and pay all its statutory payments, liabilities.

5. DES will be responsible for any loss / damages / injury/ harm caused due to any act / error / negligence , caused intentionally or unintentionally, knowingly or unknowingly by their student / students during the course of imparting of practical training and examination to the student/ students or to the Hospital Staff, Patients, Patients relatives, any third person or to the property/ belongings of hospital, hospital Staff, Patients, Patients relatives, any third person.
6. Indemnify SHPL against all and whatsoever claims, actions, suits, proceedings, taxes, levies, costs, expenses, damages, losses, injuries, harm and liabilities (including attorney's fees) which are brought against SHPL resulting from misconduct of any of the students/ persons of the College for any reason including but not limited to misrepresentation made by any of the students / persons of College or submission of fraudulent documents or details.
7. Designate one of its officials as a single point contact to decide and resolve all issues pertaining to the smooth operations of the training part of the Course, covered within the scope of this MOU and shall communicate his/her name and contact details to SHPL.
8. Maintain a register of students attending at the said Hospital for recording of attendance of the students in the premises of the said Hospital and the said registered shall be verified by the faculty member leading the batches of the other hand and / or any authorized staff of the said Hospital.
9. The said register shall remain in custody of the said College and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.

1. 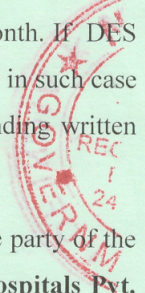
4. **LIMITATION OF TIME FOR PAYMENT :**

GOPAL RATHI, Managing Trustee, Occupation: Business, Residing at: S.No. 20/2, Sheeraj Bungalow, Gandhi Path, Near City Pride, Kothrud, Pune-411038. (which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Trustees, their heirs, Legal Representatives, Executors, Administrators, And Assigns) (Herein after referred to as Tarachand' for the sake of brevity) **The Party of the First Part**

**AND**

**DECCAN EDUCATION SOCIETY,** a society and an educational public charitable trust, having its Office at Fergusson College Campus, Fergusson Road, Shivajinagar, Pune-411004, represented by its duly authorized signatory Smt. Swati Joglekar, Secretary, Governing Body, D.E. Society, aged about 55 years, occ: Service, Address - Fergusson College, Fergusson College Campus, Pune - 411 004,

(Which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Trustees, their heirs, Legal Representatives, Executors, Administrators, And Assigns) (Herein after referred to as "DE SOCIETY" for the sake of brevity) **The Party of the Second Part**

**WHEREAS,**

- A) Seth Tarachand Ramnath Charitable Ayurvedic Hospital Trust is a Charitable Trust registered under Bombay Public Trust Act., 1950 and has established Seth Tarachand Ramnath Charitable Ayurvedic Hospital, here at Pune (Hereinafter referred to as the said "HOSPITAL" for the sake of brevity).
- B) The DE Society is a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines.
- C) The DE Society has recently established an institute by name D.E. Society's Brijlal Jindal College of Physiotherapy (hereinafter referred to as the said "COLLEGE"), with appropriate permissions from the Maharashtra University of Health Sciences, Nashik and Govt. of Maharashtra.
- D) For mutual benefits, the parties hereto agreed that for imparting of practical training (patient's treatment) and examination of the students as contemplated by the concerned syllabus, the said College is permitted to send students to the said Hospital, in consideration of the said college paying an amount of Rs. 3,00,000/- per annum from the academic year 2021-2022, to the said Hospital, and other terms and conditions enumerated below:

**NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH:**

1. **SCOPE:**

The scope of this understanding extends only to deputation of the students by D.E. Society's Brijlal Jindal College of Physiotherapy upto intake capacity for all classes, for imparting of practical training (patient's treatment) and examination as contemplated by the concerned syllabus for the discipline, in batches, led by its faculty members to the said Hospital and other incidental and ancillary matters related thereto.

2. **DURATION:**

- 2.1 The duration of this understanding shall be for the period from 01-12-2021 to 30-11-2024 unless expressly extended.
- 2.2 Both the parties can cancel or terminate the present M.O.U. by giving 3 months prior notice in writing to each other. In case of dispute, the same will be referred to the Arbitrator appointed by parties with mutual understanding whose decision will be final and binding on both the parties.



3. **AGREEMENT:**

- 3.1 Seth Tarachand Ramnath Charitable Ayurvedic Hospital hereby agrees and permits the DE Society i.e. "COLLEGE" to depute students upto its intake capacity, in batches, led by its faculty members, to the said Hospital for imparting of practical training (patient's treatments) and examination of students as contemplated by the concerned syllabus.
- 3.2 The said College shall acquaint the students with the norms discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from visiting the said Hospital
- 3.3 The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examination in the said Hospital, without however, disturbing the working of the said hospital.

4. **CONSIDERATION:**

- 4.1 In consideration of this M.O.U., the DE Society shall pay and / or caused to be paid through the said college, an amount of Rs. 3,00,000/- per annum for the above referred academic years to the said Hospital. The DE Society through the said college will pay an amount of Rs. 3,00,000/- (Rupees Three Lakhs only) as follows  
Rs.1,50,000/- on the signing of this MOU & the balance Rs.1,50,000/-before 30/07/2022 for the academic year 2021-2022.  
Similarly, the DE Society shall pay and/or caused to be paid through the said college, an amount of Rs. 3,00,000/- for the next 12 months in 2 equal instalments, each before the end of the prevailing term of 6 months.
- 4.2 The parties shall maintain a register of students attending a said Hospital for recording of attendance of the students of the campus of the said Hospital and shall be verified by the faculty member leading the batches on the other hand, and any authorized staff of the said Hospital
- 4.3 The said register shall remain in custody of the said College and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.
- 4.4 **Limitation of time for payment:**

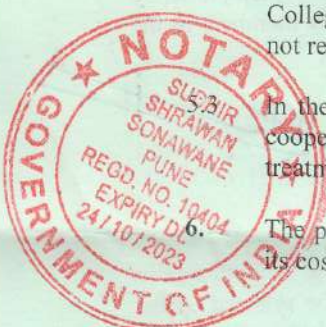
It is agreed by and between the, the D.E. Society shall pay the amounts in advance for each year. If the D.E. Society fails or neglects to pay the amount to the said Hospital in advance then in such case, the said Hospital will be entitled to revoke / cancel present M.O.U by sending written Letter by Registered Post A.D. to the D.E. Society in this behalf.

5. **OBLIGATIONS:**

- 5.1 The DE Society, the said College and the faculty leading the batches shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the campus of the said Hospital.
- 5.2 Since the matter relates to the Academic year of the concerned students of the said College, except in cases of gross indiscipline and misdemeanor, the said Hospital shall not restrain the students deputed in terms hereof.

In the very nature of the matter, the parties hereto undertake to extend all necessary cooperation to each other, so that the education of the students of the said College and treatment of patients of the said Hospital is not hampered.

The party of the one part agrees and undertakes to provide the available equipments at its costs and expenses relating to Physiotherapy O.P.D to the party of the second part





prior to the commencement of the physiotherapy practical training in the premises of the party of the second part.

Lata Mangeshkar Medical Foundation's DEENANATH MANGESHKAR HOSPITAL & RESEARCH CENTER, Near Mhatre Bridge, Erandawane, Pune – 411004. duly represented by its authorized signatories **Dr. Asmita Bhawe, Assistant Medical Superintendent, Academics** (which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Trustees, their heirs, Legal Representatives, Executors, Administrators, And Assigns) (Herein after referred to as Deenanath' for the sake of brevity) **The Party of the Second Part**

**WHEREAS,**

- A. The D.E. Society is a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines.
- B. The DE Society has recently established an institute by name D.E. Society's Brijlal Jindal College of Physiotherapy (hereinafter referred to as the said "COLLEGE"), with appropriate permissions from the Maharashtra University of Health Sciences, Nashik and Govt. of Maharashtra.
- C. L.M.M. F's DEENANATH MANGESHKAR HOSPITAL & RESEARCH CENTER, is also a trust, registered under Public Charitable Trust No. E-3068, Pune and has established L.M.M. F's DEENANATH MANGESHKAR HOSPITAL REASEARCH CENTER, here at Pune (Hereinafter referred to as the said "HOSPITAL" for the sake of brevity).
- D. The parties hereto agreed that for imparting of practical training of the students as contemplated by the concerned syllabus, the said College is permitted to send students up to its intake capacity, in batches each comprising of about 20 to 25 students to the said Hospital, in consideration of the said college paying an amount which is 15% (excluding applicable taxes) of tuition fee per student, per year to the said Hospital, and other terms and conditions enumerated below:

NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH:

1. SCOPE:
  - 1.1 The scope of this understanding extends only to deputation of 4<sup>th</sup> year students, interns and M.P.Th. students by D.E. Society's Brijlal Jindal College of Physiotherapy up to intake capacity, for imparting of practical training (patient's treatment), and clinical examination as

contemplated by the concerned syllabus for the discipline, in batches each comprising of about 20 to 25 students to the said Hospital.

- 1.2 4<sup>th</sup> year students, interns and M.P.Th. students can assist hospital therapist during therapy. Nobody will be allowed to impart therapy to patient independently or under supervision of college faculty.
- 1.3 Separate arrangements will be made for bedside teaching by rehabilitation department of the HOSPITAL.

**2. DURATION:**

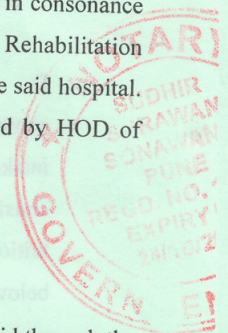
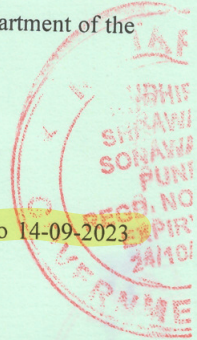
- 2.1 The duration of this understanding shall be for the period from 15-09-2020 to 14-09-2023 unless expressly extended.
- 2.2 Both the parties can cancel or terminate the present M.o.U. by giving 3 months' prior notice in writing to each other.

**3. AGREEMENT:**

- 3.1 L.M.M. F's DEENANATH MANGESHKAR HOSPITAL, RESEARCH CENTER, hereby agrees and permits the DE Society i.e. D.E. Society's Brijlal Jindal College of Physiotherapy to depute 20 to 25 students to the said Hospital for imparting of practical training to students as contemplated by the concerned syllabus.
- 3.2 The said College shall acquaint the students with the norms, discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from visiting the said Hospital.
- 3.3 The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course after seeking approval from HOD, Rehabilitation department of the said hospital, without however, disturbing the working of the said hospital. Lecture, demonstration by faculty will be allowed for the patients identified by HOD of Rehabilitation Department & after seeking permission by treating consultants.

**4. CONSIDERATION:**

- 4.1 In consideration of this MoU, the DE Society shall pay and / or caused to be paid through the said college, an amount which is 15%(excluding applicable taxes) of tuition fee per student, per year for the above referred academic years to the said Hospital.
- 4.2 D.E. Society shall maintain a register of students attending a said Hospital for recording of attendance of the students of the campus of the said Hospital and shall be verified by any authorized staff of the said Hospital.



4.3 The said register shall remain in custody of the said College and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.

4.4 **Limitation of time for payment:**

5.1 The DE Society and the said College shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the campus of the said Hospital.




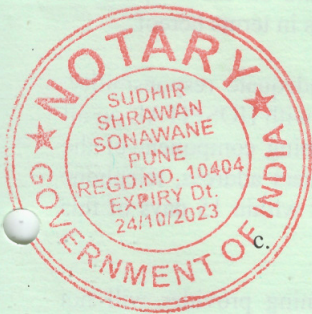
WHEREAS,

The DE Society is a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines,

a. The DE Society has established college in the name D.E.Society's Brijlal Jindal College of Physiotherapy with appropriate permissions from Government of Maharashtra and is affiliated to Maharashtra University of Health Sciences, Nashik ( hereinafter referred to as the said "COLLEGE"),

b. JEHANGIR HOSPITAL it is tertiary care, multi-specialty hospital of 350 beds which is well known in and around Maharashtra. The Jehangir Hospital has been granted Quality Management Systems Certification License as per IS/ISO 9001:2000 for the scope of its Multi-Specialty Services, by the Bureau of (India) Standards. Jehangir Hospital is a NABH accredited Hospital

(hereinafter referred to as the said " HOSPITAL' for the sake of brevity ).



For mutual benefits, the parties hereto agree that for imparting of practical training and examination of the students as contemplated by the concerned syllabus, the said College is permitted to send students upto its intake capacity, in batches each comprising of about 15 students led by its faculty members, to the said Hospital, in consideration of the said college paying an amount of Rs. 500 for UG student, Rs. 700 for PG student or intern per month per student per month for the academic year excluding examination period & vacation to the said Hospital, and other terms and conditions enumerated below :

NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:

1. SCOPE:

The scope of this understanding extends only to deputation of the students by said college upto intake capacity for all classes, for imparting of practical training and examination as contemplated by the concerned syllabus for the discipline/s in batches each comprising of about 15 students led by its faculty members to the said Hospital and other incidental and ancillary matters related thereto.

2. DURATION:

2.1 The duration of this understanding shall be for a period of three academic years i.e. from **01/04/2021 to 31/03/2024.**

2.2 Both the parties can cancel or terminate the present M.O.U. by giving 3 months prior notice in writing to each other. In case of dispute the same will be referred to the Arbitrator appointed under the Arbitration and Conciliation Act, 1996, as amended, by parties with mutual understanding, whose decision will be final and binding on both the parties.

3. **AGREEMENT :**

3.1 HOSPITAL hereby agrees and permits the college to depute students up to its intake capacity, in batches each comprising of about 15 (about half of which shall be UG student, and others PG or interns). UG students shall be led by its faculty members, to the said Hospital for imparting of practical training and examination of students as contemplated by the concerned syllabus. Hospital may accommodate the students as per its convenience.

3.2 The said College shall acquaint the students with the norms of discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from entering premises of the said Hospital.

3.3 The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said hospital.

3.4 The parties shall maintain a register of students attending at the said Hospital for recording of attendance of the students in the premises of the said Hospital and the said register shall be verified by the faculty member leading the batches of the other hand and / or any authorized staff of the said Hospital.

3.5 The said register shall remain in custody of the said college and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.

3.6 The said College shall designate one of their officials with adequate responsibility, accountability and authority as a single point interface to liaison with HOSPITAL on all issues pertaining to the smooth operations of the practical training component of the COURSE. Communicate his / her name, of execution of contact address, telephone numbers, and email ID or any change thereto, to the Hospital within 15 days of this agreement.

3.7 The said college shall ensure that the Students and the training provider will not disclose any confidential information/data of the patients. The medical information/data of the patient received during the training period shall be used only for the academic use. The college and its students shall not disclose patient related facts during and/or after the course and training.

3.8 The said college is solely responsible for any legal consequences initiated. due to such breach.

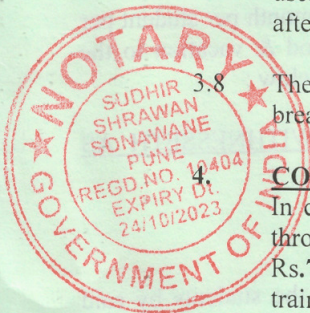
**CONSIDERATION :**

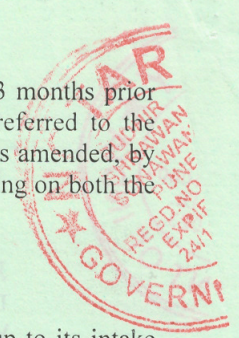

- 5.2 Since the matter relates to the Academic year of the concerned students of the said College, except in cases of gross indiscipline and misdemeanor, the said Hospital shall not restrain the students deputed in terms hereof.

This agreement is made at Pune in January two Thousand nineteen between the Director, Public Health Department Maharashtra , exercising executive power of the Govt. of state of Maharashtra ( through Civil Surgeon , Aundh Civil Hospital, Pune ) hereinafter referred to as the ' the Director' ( Which expression shall unless context does not admit include his successors) of the One Part

Shri. Dhananjay Anant Kulkarni, Secretary, Governing Body, Deccan Education Society, Pune, (which has established a Physiotherapy College named D.E. Society's Brijlal Jindal College of Physiotherapy, Pune), ( hereinafter referred to as " said College") a Society registered under Society's Registration Act, 1860 and an educational public charitable trust registered under the Bombay Public Trust Act , 1950 and having its registered office at Fergusson College Campus, Gopal Krishna Gokhale Road , Shivajinagar, Pune 411004

Hereinafter referred to as " the said College" ( Which expression shall unless the contest does not so admit, include then the survivors or survivor of them, the heirs, executors and administrators of the last survivor members or member of the time being of the Managing Committee of the said institute ) of the other part.

(hereinafter referred to as " the said Hospital") as well as other facilities available in the said Hospital for being utilized by the students of the said college for training .

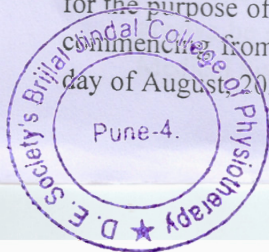
AND WHEREAS the Government has agreed to permit the said college to use the Deccan Education Society, Pune to utilize the said beds in the said Hospital, short particulars of which beds are given in the second schedule herein under written on certain terms & conditions agreed between parties hereto .

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS :-

- 1) In consideration of the grant of license by the government to Deccan Education Society, Pune to use the said hospital furniture and equipment and incidental services to be provided by the government to the said college shall pay to the government as and by way of license fee calculated at the rate of Rs. 50/- per day per bed per student used by the said college the said amount of the license fee shall be paid by the said college to concerned Civil Surgeon in advance on the first day of August to 31<sup>st</sup> August each and every year during the subsistence of this license.
- 2) In pursuant of the said agreement and in consideration of said college agrees to pay to the government license fee at the rate aforesaid at the time and in the manner hereinbefore mentioned, the Government hereby grants to the said college a license and permission to have access to and use the said only for the purpose of training students of the license institute during the period commencing from the day of 1<sup>st</sup> September 2019 and ending on the 31<sup>st</sup> day of August, 2022 .

Provided that if government is satisfied that the said college have duly performed and observed all the terms and conditions of this agreement and have achieved reasonable and / or significant progress towards the construction of and setting up of their own Hospital the Government may grant extension of this license.

- 3) This license shall extend to the employees, agents, students and such other persons as may be lawfully required by the said college for training the students of the College .
- 4) The Director, Public Health on behalf of Government hereby agrees :-

(a) That the said college may use the existing furniture, dead stock and clinical facilities belonging to the hospital for the purpose of training students of the institute. If any additional furniture, dead stock and equipment is required by the said college for training students as per the appropriate councils of India and universities requirement then the same shall be provided , installed and maintained by the said college, at their own costs. Provided that entire medical equipment of the said Hospital shall at the discretion of the Civil Surgeon / Medical Superintendent of the said Hospital, be available to all the patients of the said Hospital.

(b) That the Civil Surgeon / Medical Superintendent of the said Hospital shall be responsible for the care of the patients in the said hospital.

Provided that the exact condition and responsibility of administration, teaching and care of patients shall be worked out and fixed by mutual consultation between the Director of Health Services , Director of Medical Education & Research and the said college .

Provided also that the decision in this regard by the Director of Health/ Services on the parties hereto .

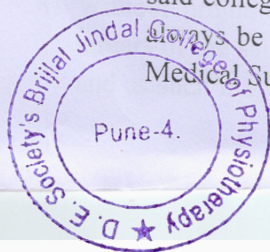
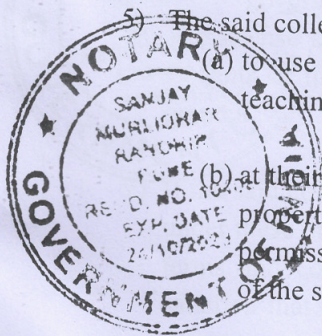
- 5) The said college undertakes and agrees :-

(Which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future directors, legal representatives Executors, Administrators and permitted Assigns, herein after referred to as "**SHPL**" for the sake of brevity) **The party of the Second Part.**

WHEREAS,

- a. The DE Society is a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines.
- b. The DE Society has established college in the name D.E.Society's Brijlal Jindal College of Physiotherapy with appropriate permissions from Government of Maharashtra and is affiliated to Maharashtra University of Health Sciences, Nashik (hereinafter referred to as the said "COLLEGE").
- c. SHPL is a company incorporated and registered under companies Act, 1956 and having its main objects of establishing and running hospitals and health care facilities. SHPL is presently running Surya Sahyadri Hospital located at 1317, Kasba Peth, Pune - 411 011 (hereinafter referred to as the said 'HOSPITAL' for the sake of brevity).
- d. The parties hereto agree that for imparting of practical training and examination of the students as contemplated by the concerned syllabus, the said College is permitted to send students upto its intake capacity, in batches each comprising of about 25 – 30 students led by its faculty members, to the said Hospital, in consideration of the said College paying an amount of Rs. 500/- (Five hundred only) plus applicable taxes and Rs.600/- (Rs. Six hundred only) per PG student/ Intern plus applicable taxes per student per month for the academic year excluding examination period & vacation to the said College, and other terms and conditions enumerated below :


NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:

1. **SCOPE :**

The scope of this understanding extends only to deputation of the students by said College upto its intake capacity for all classes, for imparting of practical training and examination as contemplated by the concerned syllabus for the discipline/s in batches each comprising of about 25-30 students led by its faculty members to the said Hospital and other incidental and ancillary matters related thereto.

2. **DURATION :**

- 2.1 The duration of this understanding shall be for a period of three academic years starting from 1<sup>st</sup> March, 2020 up to 28<sup>th</sup> February, 2023, unless renewed in writing.
- 2.2 Either party can cancel or terminate this MOU. by giving 3 months' prior notice in writing to the other party. In case of dispute, the same will be referred to the Sole Arbitrator appointed under the Arbitration and Conciliation Act, 1996, by parties with mutual understanding, whose decision will be final and binding on both the parties and the arbitration proceedings shall be held at Pune.

### **3. AGREEMENT :**

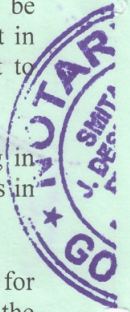
- 3.1 SHPL hereby agrees and permits the College to depute students up to its intake capacity, in batches each comprising of about 25 – 30 students led by its faculty members, to the said Hospital for imparting of practical training and examination of students as contemplated by the concerned syllabus.
- 3.2 The said College shall acquaint the students with the norms of discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from entering premises of the said Hospital.
- 3.3 The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said hospital.
- 3.4 The parties shall maintain a register of students attending at the said Hospital for recording of attendance of the students in the premises of the said Hospital and the said register shall be verified by the faculty member leading the batches of the other hand and / or any authorized staff of the said Hospital.
- 3.5 The said register shall remain in custody of the said College and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.

### **4. CONSIDERATION :**

- 4.1 In consideration of this MOU, the DE Society shall pay (and / or caused to be paid through the said College, an amount of Rs. 500/- (Five Hundred only) per UG student per month plus applicable taxes( GST)and Rs. 600/- (Rs. Six hundred only) per PG student/ Intern plus applicable taxes ( GST) when raised by hospital as workshop fees during the period of their training in the said Hospital, with yearly increase of 5%. DE Society shall be responsible for payment of applicable taxes (including service tax) under this MOU.
- 4.2 The Party of the First Part shall be entitled to send UG & PG students and interns for the training programme under this MOU. If the number of students or interns is increased, the payment shall be made on pro rata basis.
- 4.3 Limitation of time for payment.
- 4.3.1 It is agreed by and between the parties that after the expiry of month in which the training was imparted to the student by the said Hospital, the D.E.Society shall pay the amount to be calculated as per number of student within seven days from the date of expiry of each month. If D.E.Society fails or neglects to pay the amount to the said Hospital consecutively for three months, in such case the said Hospital will be entitled to revoke / cancel present M.O.U by sending written Letter by Registered Post A.D. to D.E. Society in this behalf.
- 4.2.2 It is agreed by and between the parties that the party of the first part shall make the payment to the party of the second part by NEFT/ RTGS in the concerned bank provided by the hospital .

### **5. OBLIGATIONS :**

- 5.1 The DE Society, the said College and the faculty leading the batches shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the premises of the said Hospital.




- 5.4 Each Party shall be responsible for obtaining necessary statutory licenses, permissions, etc. and for making the statutory compliance as may be applicable to it and to give effect to this Agreement and shall not hold the other party responsible for it.


**CONFIDENTIALITY:**

# “Support for providing physiotherapy services to Elderly Population in slums and in Geriatric Units of Pune Municipal Corporation”

## Purpose

The purpose of this Memorandum of Understanding (MOU) is to formally create a mutually beneficial working relationship between Society of Community Health Oriented Operational Links (SCHOOL) and DES Brijlal Jindal college of Physiotherapy on providing support for the physiotherapy care to the elderly population in 60 slums of Pune Municipal Corporation.’

## Background

### About Society of Community Health Oriented Operational Links (SCHOOL)

Society of Community Health Oriented Operational Links (SCHOOL) is a not-for-profit organization founded in the year 2007. SCHOOL works diligently with the communities to ensure development and bring about a visible impact in their lives. With a strong focus on empowerment and participation, Society of Community Health Oriented Operational Links (SCHOOL) practices the unique approach of addressing the social determinants. It consists of programs and focus areas with an end goal in sight of protecting vulnerable populations.

‘Vridha Mitra’ (earlier known as Healthy Ageing) a flagship initiative of SCHOOL focuses on building an age friendly ecosystem for the elderly population in India. The key pillars of the initiative are:

1. Improving reach by implementing community-based projects for bottom of the pyramid elderly population
2. Creating helpline, day care centers, physiotherapy clinics for providing support to elderly people.
3. Advocacy for building age-friendly cities/ localities
4. Sensitizing the younger generation on the issues of elderly people and creating inter-generational dialogue

‘Vridha Mitra’ field project in Pune works with **5400 elderly people in Pune city**, wherein the focus is on building an age friendly ecosystem for the elderly residents of slums.

### About Brijlal Jindal, college of Physiotherapy, Shivajinagar, Pune

- A. The DES a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines,
- B. The DES has established college in the name D.E. Society’s Brijlal Jindal College of Physiotherapy with appropriate permissions from Government of Maharashtra and is affiliated to Maharashtra University of Health Sciences, Nashik (hereinafter referred to as the said “COLLEGE”),

## The concept

DES Brijlal Jindal College of Physiotherapy, Shivajinagar, Pune & Society of Community Health Oriented Operational Links (SCHOOL) agree to enter into a working relationship where both organizations will jointly implement field activities specially to fulfill the physiotherapy needs of the elderly population in 65 slums at 10 locations/ clusters of Pune City and persons coming at ‘Geriatric Unit’ at Dalvi Hospital and Sonawane Hospital (both jointly run by SCHOOL and PMC), located at Shivajinagar and Bhavani peth respectively in Pune.

## Scope of the agreement:

- Need assessment to understand the level of required efforts for physiotherapy for the elderly (aged 60 years and above) people in mutually decided slums in Pune City of Maharashtra state.
- To provide existing interns and/or undergraduate and post graduate students for providing support for physiotherapy services to the elderly based on individual care plan and ensuring appropriate referrals.
- Collaboration for research: - Data collected in these treatment sessions will be utilized by both the parties for research and analysis, while maintaining subject confidentiality. Papers generated using this data will be sent for each other’s comments.



## OBLIGATIONS:

- The D.E. Society and the said College shall be responsible for maintenance of discipline, directives, decorum and good behaviour of and by the students at the centre.
- In the very nature of the matter, the parties hereto undertake to extend all necessary cooperation to each other, so that evaluation & treatment of the residents of the centre is not hampered.
- It shall be obligatory on the party of the second part to provide the necessary access & assistant to college students during the treatment session as per the decided schedule and the students will also get a practical experience adding value to their professional course and also for conducting examination of the students as and when required without hampering the functioning of the center.

## **Expenditures**

This MOU will be treated as Non-Financial agreement

## **Differences in interpretation and application**

Society of Community Health Oriented Operational Links (SCHOOL) & Brijlal Jindal College of Physiotherapy, Shivajinagar, Pune will resolve any difference in interpretation and application of this working relationship through negotiation and round table discussion.

## **Method of Cooperation**

SCHOOL agrees to work with staff of Brijlal Jindal College of Physiotherapy, Shivajinagar, Pune to carry out the scope of work as defined above. SCHOOL will work with Brijlal Jindal College of Physiotherapy, Shivajinagar, Pune to support in its true intent for project-specific deliverables. For each of the project in future too, clear and transparent roles and responsibilities with defined deliverables will be discussed and agreed upon by both parties.

## **Indemnification**

Each party to this agreement shall indemnify and hold the other party harmless against any legal claims, damages, liabilities, or causes of action brought against them.

## **Memorandum of Understanding (MOU) Commitments**

Society of Community Health Oriented Operational Links (SCHOOL) & Brijlal Jindal College of Physiotherapy, Shivajinagar, Pune recognizes the importance of collaboration to complete a set of activities as defined in this MoU. Consequently, the Parties are hereby establishing a working relationship, for a period of three years from the date **1<sup>st</sup> September, 2022 to 31<sup>st</sup> August, 2025.**

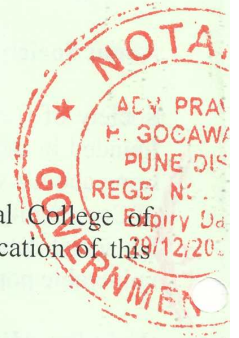
## **Terms and conditions**
