MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING is made on this day of 21 May of year 2018 and between **DES Brijlal Jindal college of PT, Pune**, a teaching institute having registered their place at **Shivaji Nagar, Pune** and **PT school and centre, Seth GSMC and KEMH, Mumbai** formed and registered having their place of work at **Parel, Mumbai**.

RECITALS-

- 
1. The PT school and center, Seth GSMC and KEMH, Mumbai is desirous to conduct research in the area of Musculoskeletal Sciences and execute a project titled, "Assessment of Movement dysfunction of lumbopelvic hip complex and performance related fitness in subjects participating in yoga"
 2. The DES Brijlal Jindal college of PT, Pune is also desirous to conduct a similar research project and would be involved in the same to extent laid down in this MOU.
 3. The purpose of the project is study to assess lumbopelvic hip complex and performance related fitness in yoga participants in order to identify the risk factors for musculoskeletal injuries.
 4. The outcome measures of the project shall be conducted through analytical tools, preliminary information and the findings will be helpful for yoga participant to prevent yoga related musculoskeletal injuries.

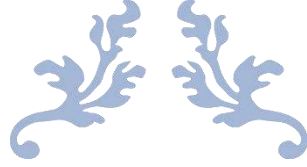

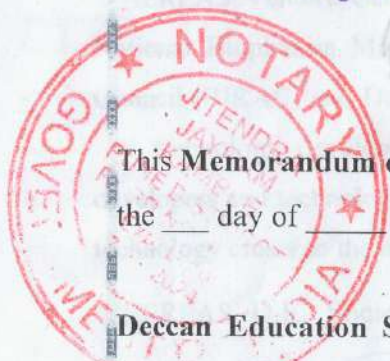

This Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on this the ___ day of ___

BETWEEN

Deccan Education Society's Brijlal Jindal college of Physiotherapy, Fergusson College Campus, Deccan Gymkhana, Pune, Maharashtra 411004, the First Party represented herein by Smt. Swati C. Joglekar, Secretary, Governing Body, DE Society, aged about 54 years, occ: Service,



occ: Service, Address – Fergusson College Campus, Shivajinagar, Pune – 411004.

(which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Trustees, their heirs, Legal Representatives, Executors, Administrators, And Assigns) (Herein after referred to as “DE SOCIETY” for the sake of brevity) The Party of the First Part

AND

Entrepreneurship Development Center, an Indian Non-profit Company registered under section 8 of The Companies Act- 1956, having its registered office at 100, NCL Innovation Park, CSIR-NCL Campus, Dr. Homi Bhabha Road, Pune-411008, Maharashtra, India, hereinafter referred to as **Venture Center**, which expression shall unless repugnant to context include its successors, executors and assignees,

Both herein after referred to as the “Parties” collectively, or “Party” individually.

1. PREAMBLE

WHEREAS Venture Center is a non- profit technology business incubator (TBI) hosted by CSIR-National Chemical Laboratory, Pune specializing in science and technology based startups in a wide array of market sectors and scientific disciplines. Venture Center is a TBI created under a scheme of CSIR (Government of India), approved by DST-NSTEDB (MoS&T, Govt of India). Venture Center is recognized as a NIDHI-Center of Excellence by DST-NSTEDB. Venture Center is also a BIRAC (Department of Biotechnology, Govt of India) supported bio incubator that is nurturing several biotech/biomed startups and innovators. BIRAC has selected Venture Center to host the BIRAC Regional BioInnovation Center and the Center for Biopharma Analysis. Venture Center has been awarded the National Award for Technology Business Incubators from the President of India on 11 May 2016, the AABI (Asian) Incubator of the Year 2018 and National Entrepreneurship Award under the Ecosystem Builder Category 2019 and National Award for best Incubator for nurturing IP 2021-22

WHEREAS Venture Center has formed a technology transfer hub -TechEx.in with support from the National Biopharma Mission (NBM) – an initiative of Biotechnology Industry Research Assistance Council (BIRAC) and Department of Biotechnology (Government of India), to help and assist inventors and technology developers seek formal IP protection, market their technologies, help technology developers and technology commercialization entities find each other, forge partnerships and advance the technology closer to the market in a win-win partnership.

WHEREAS D.E. Society Brijlal Jindal College of Physiotherapy has plans to strengthen its

innovation promotion, IP protection and technology commercialization capabilities and has expressed an interest in engaging with partners with complementing activities and interests.

WHEREAS, given the commonality of objectives, Venture Center has agreed to make accessible its various TechEx.in services to D.E. Society Brijlal Jindal College of Physiotherapy as mentioned in Appendix 1.

Given the complementarities of their objectives and aligned interests, the Parties therefore decided to enter into a MoU to secure those objectives by mutual cooperation.

2. INTERPRETATION AND DEFINITIONS

Subject to the context hereof the following words and expressions shall be construed and interpreted so as to have the following meaning.

- 2.1 **Effective Date:** shall mean the date of signing of this agreement by both parties.
- 2.2 **Technology:** shall mean D.E. Society Brijlal Jindal College of Physiotherapy technical know how, technical knowledge and information, and/or patents and patent applications.
- 2.3 **IP:** Intellectual Property shall mean Knowhow, confidential information, Patents, trademarks, Industrial Designs and IC Layout Designs and Copyrights if any.



3. TERM OF MOU

- 3.1 This MoU shall remain in force for a period 12 months from the Effective date.
- 3.2 The term of the MoU as specified in 3.1 may be extended to such further terms as mutually decided by the parties in consultation with each other, which shall not be more than 35 months in all including the first 12 months.

4. SCOPE OF MOU

- 4.1 Venture Center agrees to partner with D.E. Society Brijlal Jindal College of Physiotherapy and D.E. Society agrees to accept VentureCenter as a partner.
- 4.2 Both Venture Center and D.E. Society Brijlal Jindal College of Physiotherapy agree to designate one nodal person from each side to coordinate and facilitate implementation of this MoU. On behalf of D.E. Society Brijlal Jindal College of Physiotherapy, Dr. Snehal Joshi will be the nodal person as point of contact. On behalf of Venture Center, Dr. Kavita Parekh will be the nodal person as point of contact. The relationship under this MoU shall be mutually non-exclusive.

4.3 Responsibilities of Venture Center

4.3.1 Venture Center agrees to invite D.E. Society Brijlal Jindal College of Physiotherapy for all the open talks, seminars and events.

4.3.2 Venture Center will arrange and announce free of cost mentoring and advisory clinics open to all its Strategic Partners including the D.E. Society Brijlal Jindal College of Physiotherapy. The mentoring clinics will be held roughly once a month. D.E. Society Brijlal Jindal College of Physiotherapy will be required to sign up for the above clinics and book the slots on a first come as per availability.

4.3.3 Venture Center agrees to make accessible discounted TechEx.in services (as listed in the Appendix1) to D.E. Society Brijlal Jindal College of Physiotherapy subject to a) availability, b) D.E. Society Brijlal Jindal College of Physiotherapy agreeing to all terms & conditions applicable to specific services and c) payment of applicable fees. The D.E. Society Brijlal Jindal College of Physiotherapy may or may not choose to avail of these services as per requirement and as allowed by its rules.

4.3.4 Venture Center will provide access to occasional funding support for patent filing and/ or tech transfer training announced by NBM-BIRAC as and when available.

4.4 Responsibilities of D.E. Society Brijlal Jindal College of Physiotherapy

4.4.1 D.E. Society Brijlal Jindal College of Physiotherapy shall identify a single point contact at D.E. Society Brijlal Jindal College of Physiotherapy

4.4.2 D.E. Society Brijlal Jindal College of Physiotherapy shall acknowledge and credit Venture Center (a registered Service mark of Entrepreneurship Development Center) as Innovation Management Support provided by TechEx.in, the RTTO supported by Venture Center and National Biopharma Mission wherever applicable.

4.4.3 In order to reduce any misunderstandings or duplication of work, the D.E. Society Brijlal Jindal College of Physiotherapy shall inform Venture Center of any parallel efforts by other partners'/ service providers with regards to services offered by Venture Center.


4.5 Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MOU.

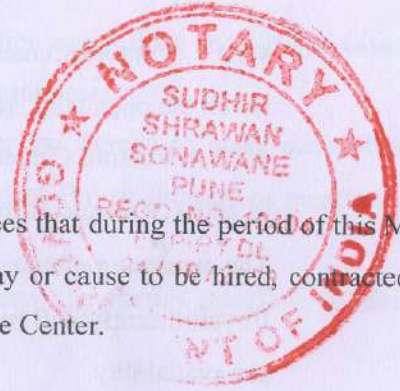

6. NON-SOLICITATION

D.E. Society Brijlal Jindal College of Physiotherapy agrees that during the period of this MoU and 6 months after that, it will not hire, contract or take away or cause to be hired, contracted or taken away any employee or independent contractor of Venture Center.



7. AMENDMENTS

7.1 This MoU is the sole repository of the mutually agreed covenants between the parties. The MoU may be amended by mutual consent and the amendments shall be applicable from the date of such amendments unless agreed to contrary.

7.2 Any matter not provided for in this MoU may be discussed and any agreement on such matter maybe added in this MoU as addendum by reducing such agreement in writing. Any such addendum shall be deemed to be an integral part of the MoU.

8. TERMINATION

The parties have the option to withdraw from any or all areas of cooperation covered by this MoU by giving a notice of not less than 10 days in writing to the other party, informing the cause(s) for termination. However, the provisions of confidentiality shall bind both parties.

9. NOTICES

WHEREAS,

- A. The D.E. Society is a Society registered under the Society's Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act, 1950, pursuing its objects of imparting formal and informal education in various disciplines.
- B. The DE Society has established a college by name D.E.Society's Brijlal Jindal College of Physiotherapy (hereinafter referred to as the said "COLLEGE"), with appropriate permissions from the Maharashtra University of Health Sciences, Nashik and Govt. of Maharashtra.
- C. **Fit2Sport** is a private clinic rendering treatment / consultancy for various sport players of all major categories from national to international levels also catering to non-surgical Musculoskeletal issues, pre and post surgical rehab.
- D. The parties hereto agree that the said College will send students (UG, PG & Interns) to the clinic to administer physiotherapy training & treatment as required to the players and also to extend physiotherapy support for the tournaments at national & or at international levels in which the clinic players would be participating.

NOW, THIS MEMORANDUM OF UNDERSTANDING WTTIHNESSETH:

1. SCOPE:

1. The scope of this understanding extends only to deputation of UG students, interns and M.P.T. students by D.E.Society's Brijlal Jindal College of Physiotherapy for clinical examination, training and administering treatment to the venue of clinic and or all tournaments undertaken by Fit2Sport.
2. UG students, interns and M.P.T. students can treat/ train the clinic players of Fit2Sport under the supervision of the college faculty (as and when required).
3. The treatment given to the players would be non-invasive

2. DURATION:

- 2.1 The duration of this MoU shall be for the period from **01-02-2020 To 31-01-2023.**

- 2.2 Both the parties can cancel or terminate the present MoU by giving 3 months prior notice in writing to each other.

3. AGREEMENT:

1. The clinic, hereby agrees and permits the DE Society i.e. D.E. Society's Brijlal Jindal College of Physiotherapy to depute students to the said clinic & tournament venue to administer physiotherapy training & treatment as required to the clinic players at the said venue.

4. CONSIDERATION:

1. D.E. Society shall maintain a register of students attending a said clinic / tournament venue for recording of attendance of the students for that particular posting.
2. The said register shall remain in custody of the said College.



3. There is no financial consideration to be paid by parties to this MoU.
5. **OBLIGATIONS:**

1. The D E Society's Brijlal Jindal College of Physiotherapy shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the day of treatment of the players of the clinic at the concerned venue.

6. **ARBITRATION:**

Executors, Administrators and Assigns, hereinafter referred to as **DES** for the sake of brevity) **The party of the first part.**



And

SAHYADRI HOSPITAL PVT LTD, (Previously known as **SAHYADRI HOSPITAL LTD**) a company registered under Companies Act, 2013 with **CIN U85110PN1996PTC099499** and having its Registered Office at **S.NO.89 &90, PLOT NO. 54, LOKMANY COLONY KOTHRUD, PUNE - 411038** duly represented by **CHIEF EXECUTIVE OFFICER MR. ABRARALI DALAL**

(Which expression shall unless there be anything repugnant to the subject or contrary to the context mean and include its present and future Directors, their successors and permitted assigns, herein after referred to as **'SHPL'** for the sake of brevity) **THE PARTY OF THE SECOND PART.**

WHEREAS,

- A.** The **DES** a Society registered under the Societies Registration Act., 1860, so also is an educational charitable trust, under the Bombay Public Trust Act., 1950, pursuing its objects of imparting formal and informal education in various disciplines.
- B.** The **DES** has established college in the name **D.E.Society's Brijlal Jindal College of Physiotherapy** with appropriate permissions from Government of Maharashtra and is affiliated to Maharashtra University of Health Sciences, Nashik (hereinafter referred to as the said **"COLLEGE"**),
- C.** **SHPL** is a company incorporated and registered under companies Act, 2013 and having its main objects of establishing and running hospitals and health care facilities. **SHPL** is presently running / managing various hospitals, pathology labs and diagnostics centers in Pune as well as the rest of Maharashtra. **SHPL** is running and managing Sahyadri Super Specialty Hospital located at Karve Road, Pune (hereinafter referred to as the said **"HOSPITAL"** for the sake of brevity).
- D.** For mutual benefits, the parties hereto agree that for imparting of practical training and examination of the students as contemplated by the concerned syllabus, the said College is permitted to send students up to its intake capacity, in batches each comprising of about 25 – 30 students led by its faculty members, to the said Hospital, in view of the said College paying Consideration as stated in clause D herein below of this MOU excluding examination period & vacation to on the terms and conditions enumerated below
- E. NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:**
 - A. SCOPE :**

The scope of this understanding extends only to deputation of the students by said college up to intake capacity for all classes, for imparting of practical training and examination as contemplated by the concerned syllabus for the discipline/s in batches each comprising of about 25-30 students led by its faculty members to the said Hospital and other incidental and ancillary matters related thereto.

B. DURATION:

- 1 The duration of this understanding shall be for a period of three academic years i.e. from **01st June 2021 to 31st May 2024**, unless renewed in writing by both the parties.
- 2 Both the parties can cancel or terminate the present MOU by giving 3 months prior notice in writing to other party. However, in case of breach of any of the terms of this MOU, SHPL reserves the right to terminate this MOU forthwith.

C. OBLIGATIONS

(a) Obligation of SHPL :

- 1 SHPL hereby agrees and permits the college to depute students up to its intake capacity, in batches each comprising of about 25 – 30 students led by its faculty members, to the said Hospital for imparting of practical training and examination of students as contemplated by the concerned syllabus.
- 2 Provide support and facilities to the College to hold practical training in consonance with the syllabus prescribed for the Course in the premises.
- 3 Designate one of its officials as a single point contact to decide and resolve all issues pertaining to the smooth operations of the training part of the Course covered within the scope of this MOU and shall communicate his / her name and contact details to the said College .
- 4 Allow the students and training providers to enter the Hospital premises for the purpose of attending training sessions; the Hospital reserves the right to restrict any student or person from entering its Hospital premises for any disciplinary or other issues.

1. The said College shall acquaint the students with the norms of discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from entering premises of the said Hospital.
2. The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said hospital.

6. Indemnify SHPL against all and whatsoever claims, actions, suits, proceedings, taxes, levies, costs, expenses, damages, losses, injuries, harm and liabilities (including attorney's fees) which are brought against SHPL resulting from misconduct of any of the students/ persons of the College for any reason including but not limited to misrepresentation made by any of the students / persons of College or submission of fraudulent documents or details.
7. Designate one of its officials as a single point contact to decide and resolve all issues pertaining to the smooth operations of the training part of the Course, covered within the scope of this MOU and shall communicate his/her name and contact details to SHPL.
8. Maintain a register of students attending at the said Hospital for recording of attendance of the students in the premises of the said Hospital and the said registered shall be verified by the faculty member leading the batches of the other hand and / or any authorized staff of the said Hospital.
9. The said register shall remain in custody of the said College and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.

D. CONSIDERATION :

1. In consideration of this MOU, the DES shall pay (and / or caused to be paid through the said College, an amount of **Rs. 600/-** (Six Hundred only) excluding all applicable taxes per UG student per month as workshop fees and **Rs. 700/-** (Rs. Seven Hundred only) excluding all applicable taxes per PG student/ Intern per month as workshop fees during the period of their training in the said Hospital.
2. Thereafter there shall be increase at the rate of 5% in the workshop fees every year.
3. Taxes will be charged extra as applicable. SHPL shall issue invoice for the consideration payable by DES including applicable taxes by 5th of each month.

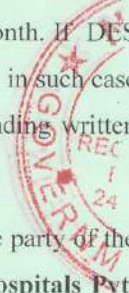

The parties hereto agreed that for imparting of practical training of the students as contemplated by the concerned syllabus, the said College is permitted to send students up to its intake capacity, in batches each comprising of about 20 to 25 students to the said Hospital, in consideration of the said college paying an amount which is 15% (excluding applicable taxes) of tuition fee per student, per year to the said Hospital, and other terms and conditions enumerated below:

NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH:

1. **SCOPE:**
 - 1.1 The scope of this understanding extends only to deputation of 4th year students, interns and M.P.Th. students by D.E. Society's Brijlal Jindal College of Physiotherapy up to intake capacity, for imparting of practical training (patient's treatment), and clinical examination as

contemplated by the concerned syllabus for the discipline, in batches each comprising of about 20 to 25 students to the said Hospital.

- 1.2 4th year students, interns and M.P.Th. students can assist hospital therapist during therapy. Nobody will be allowed to impart therapy to patient independently or under supervision of college faculty.
- 1.3 Separate arrangements will be made for bedside teaching by rehabilitation department of the HOSPITAL.

2. **DURATION:**

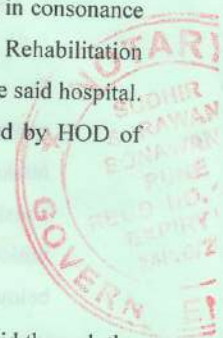
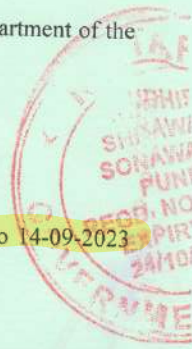
- 2.1 The duration of this understanding shall be for the period from 15-09-2020 to 14-09-2023 unless expressly extended.
- 2.2 Both the parties can cancel or terminate the present M.o.U. by giving 3 months' prior notice in writing to each other.

3. **AGREEMENT:**

- 3.1 L.M.M. F's DEENANATH MANGESHKAR HOSPITAL, RESEARCH CENTER, hereby agrees and permits the DE Society i.e. D.E. Society's Brijlal Jindal College of Physiotherapy to depute 20 to 25 students to the said Hospital for imparting of practical training to students as contemplated by the concerned syllabus.
- 3.2 The said College shall acquaint the students with the norms, discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from visiting the said Hospital.
- 3.3 The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course after seeking approval from HOD, Rehabilitation department of the said hospital, without however, disturbing the working of the said hospital. Lecture, demonstration by faculty will be allowed for the patients identified by HOD of Rehabilitation Department & after seeking permission by treating consultants.

5.1 The DE Society and the said College shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the campus of the said Hospital.




In case of dispute the same will be referred to the Arbitrator appointed under the Arbitration and Conciliation Act, 1996, as amended, by parties with mutual understanding, whose decision will be final and binding on both the parties.

3. **AGREEMENT :**

3.1 HOSPITAL hereby agrees and permits the college to depute students up to its intake capacity, in batches each comprising of about 15 (about half of which shall be UG student, and others PG or interns). UG students shall be led by its faculty members, to the said Hospital for imparting of practical training and examination of students as contemplated by the concerned syllabus. Hospital may accommodate the students as per its convenience.

3.2 The said College shall acquaint the students with the norms of discipline to be followed while on the campus of the said Hospital, with appropriate notice that in case of any indiscipline by any of the students, the Hospital shall have right to restrict him or her from entering premises of the said Hospital.

3.3 The said College is permitted to hold its practical and / or theoretical training in consonance with the syllabus prescribed for the course and to hold examinations in the said Hospital, without however, disturbing the working of the said hospital.

3.4 The parties shall maintain a register of students attending at the said Hospital for recording of attendance of the students in the premises of the said Hospital and the said register shall be verified by the faculty member leading the batches of the other hand and / or any authorized staff of the said Hospital.

3.5 The said register shall remain in custody of the said college and on each deputation shall be brought to the said Hospital for verification by the parties in terms hereof.

3.6 The said College shall designate one of their officials with adequate responsibility, accountability and authority as a single point interface to liaison with HOSPITAL on all issues pertaining to the smooth operations of the practical training component of the COURSE. Communicate his / her name, of execution of contact address, telephone numbers, and email ID or any change thereto, to the Hospital within 15 days of this agreement.

3.7 The said college shall ensure that the Students and the training provider will not disclose any confidential information/data of the patients. The medical information/data of the patient received during the training period shall be used only for the academic use. The college and its students shall not disclose patient related facts during and/or after the course and training.

3.8 The said college is solely responsible for any legal consequences initiated. due to such breach.

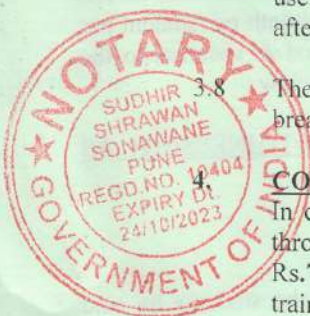
CONSIDERATION :

In consideration of this MOU, the DE Society shall pay (and / or caused to be paid through the said college, an amount of Rs. 500 /- per UG student per month and Rs.700/- per PG student/ Intern per month as workshop fees during the period of their training in the said hospital for the period of examination & vacation. The Payment made is non-refundable. Such payable amount will be paid to Hospital irrespective of the fees collected from the student,

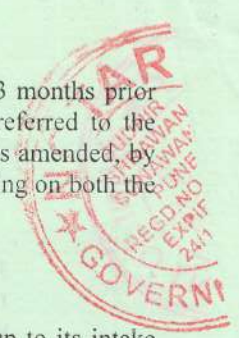
4.1 Limitation of time for payment.

4.2.1

It is agreed by and between the parties that after the expiry of month in which the training was imparted to the student by the said Hospital, the D.E.Society shall pay the amount to be calculated as per number of student within seven days from the date of expiry of each month. If D.E. Society fails or neglects to pay the amount to the said Hospital consecutively for three months, in such case the said Hospital will be entitled

- 4.2.2 In the event that a student, assigned to HOSPITAL drops out during the month said college will endeavor to replace that student with a new student. However, the said college shall pay the total monthly consideration to the Hospital,

It is agreed by and between the parties that the party of the first part shall make the payment to the party of the second part by Account Payee Cheques to be drawn in the name of "JEHANGIR HOSPITAL"

5. **OBLIGATIONS :**

- 5.1 The DE Society, the said College and the faculty leading the batches shall be responsible for maintenance of discipline, directives, decorum and good behavior of and by the students on the premises of the said Hospital.
- 5.2 Since the matter relates to the Academic year of the concerned students of the said College, except in cases of gross indiscipline and misdemeanor, the said Hospital shall not restrain the students deputed in terms hereof.
- 5.3 In the very nature of the matter, the parties hereto under take to extend all necessary cooperation to each other, so that the education of the students of the said College is not hampered.
